

#### **ONLINE PRIVACY POLICY AGREEMENT**

This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Systems Liaison LLC does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.
